

1. Name of the post : A) Director (Finance) – **One Post** for Delhi Transco Limited (DTL) & Delhi Power Company Limited (DPCL)

5. Terms & Conditions : The terms and conditions of deputation as laid down in the Ministry of Personnel, Public Grievances and Pension, Govt. of India, Department of Personnel and Training O.M.4/78/2006-P & PW(D) dated 31.10.2007 shall be applicable during deputation.
